Recommendations:

- ▷ Manager (How would you manage the group and your contributions?)
- ▷ Counselor (How would you support the artists and what advice would you give?)
- ▷ Screenwriter (The realization of their own format that allows the team to perform it and that they can interpret the text)

Terms and conditions:

- ▷ There are no age, nationality, weight and / or gender restrictions.
- ▷ The present must have a mobile device and / or computer, this because we are an international and totally virtual agency.
- ▷ If you apply to be a tutor, you can choose the hours that are appropriate, but you must take into account that these do not influence much with the schedules of the other classes and that it is at least once a week.
- ▷ There will also be meetings which will be notified in advance, these always within the hours of 9:00 am to 3:00 pm (Colombia)
- ▷ The identity of the people who are part of the agency must be kept confidential and their privacy respected.
- ▷ Do not disclose personal information of the people of the company.
- ▷ Confidentiality with the company's projects.
- ▷ Visual and musical Producers, Trainers, Managers, Screenwriter and Counselors. They are going to be considered as a public figure, therefore you must be careful when publishing content, be careful with disrespect in networks and other spaces.

Meeting:

Once your answer is registered, you will be notified if you have passed your audition, if you have been accepted you must attend an interview with the CEO and Sub CEOs.

Admission and Trial Period:

In case of being admitted, he will be put on a probationary period depending on the position for which he has auditioned.
