1. Terms and Information:

- 2.4. Taking into account that artists will be considered public figures, care must be taken when posting content on social networks and other public spaces, avoiding disrespect or generating controversy.

3. Admission process:

- 3.1. Once your answer is recorded, you will be notified if you have passed your audition.
- 3.2. If you have passed, you must appear for an interview and second audition by video call.
- 3.3. Notification to those who passed the interview and second audition: Once the interview and second audition are completed via video call, selected candidates will be notified via email or text message.
